
MAA is currently operating in the South Pacific region with countries such as Fiji, Vanuatu and Tonga.

MAA is also a signatory to the "Australian Council for International Development" Code of Conduct.


A key purpose of (ACFID) is to equip and encourage members to observe the highest ethical standards in all their activities.

Dear Stakeholder of MAA,

It is my pleasure to present to you yet again an annual report of another extremely successful year for MAA. Indeed, 2017 proved to be another solid year for us; making it the sixth year in a row.

MAA has been measuring high across all the Key Performance Indicators (KPIs):

- Achieving recognition for our Trustworthiness, Transparency, and Efficiency;
- Achieving a 100% Project Success rate;
- Maintaining 100% Compliance, Governance, and Transparency;
- Doing the right thing... Right!
- Designing, growing and strengthening our Ethical Sustainable Development solutions for our beneficiaries.

I would like to take this opportunity to share some fantastic news with you. In 2017, MAA attained the Australian Government's Department of Foreign Affairs & Trading (DFAT) accreditation. DFAT mentions in their website that 'accreditation of Australian

NGOs is a front-end and rigorous risk-management process which is also a robust due diligence process for DFAT. To gain accreditation, NGOs are required to undergo a thorough and independent assessment of their organisational structure, systems, policies, and philosophies against an agreed set of criteria. NGOs must demonstrate capacity and performance against a range of indicators and may seek accreditation at either Base or Full level'.

The DFAT accreditation came after the attainment of the full membership of the Australian Council for International Development in 2016 (ACFID). ACFID is the peak body for Australian Non-Government Organisations (NGOs) involved in international development and humanitarian aid.

These two major accreditations demonstrate the commitment of MAA to the highest levels of compliance, transparency, and cooperation with peak bodies like ACFID and DFAT. We take compliance very seriously and have established policies and put processes in place, including key policies addressing Anti-Money Laundering, Anti-Fraud, Counter-Terrorism and Child Protection that strengthen our Corporate Risk Management. Closely working with ACFID, DFAT and peer organisational members also ensures optimal co-ordination and exchange of best practices. All this means that it is even more safer to donate, support and partner with MAA.

In 2017, we continued to grow our life-changing, impactful and sustainable solutions. We grew these programs from ~\$3.4M in

2016 to ~\$3.8M in 2017.

Highlights of 2017 include:

- Attaining the DFAT base accreditation
- Keeping the Australian Charities and Not-for-profit Commission (ACNC) blue tick, that reassures the public that MAA is transparent and accountable by highlighting its presence on the ACNC Charity Register.
- Keeping the ACFID and the ACNC membership with the ontime fulfilment of our compliance requirements and reporting.
- Growing programs disbursements from ~\$11.9M in 2016 to ~\$12.1 in 2017.
- MAA's effective accountability and admin ratio, and fundraising ratio continues to be a world-class low of 6.6% and 2.2% respectively.
- Our support for sustainable programs grew from ~\$3.4M in 2016 to ~\$3.8M in 2017, demonstrating our commitment to the vision of working towards an ethical, sustainable planet.

A hearty thank you to all MAA stakeholders supporters, donors, partners, ACFID and DFAT, without whom we would not have been able to achieve such fantastic results. There is a lot more to do in the future.

Australian Government

Department of Foreign Affairs and Trade

In 2017, MAA became the first and only Islamic NGO to be accredited by the Australian Government's Department of Foreign Affairs & Trade (DFAT).

The DFAT accreditation process, rigorously assesses our governance, program management capacity, policies, risk, and partner management.

Among other benefits, the accreditation means that MAA International is now also eligible to receive funding through the Australian NGO Cooperation Program (ANCP).



CORPORATE GOVERNANCE

Internal control & governance are integral parts of our day-to-day operations. Policies, Processes, Key Performance Indicators and Systems are in place to ensure effective governance.

Ongoing monitoring, reporting and internal controls are undertaken and reviewed by the executive team to ensure all operations are aligned to achieve the charity's purpose. These include the following: -

- The constitution represents the overarching rules of the organisation. The constitution contains all the necessary rules reflecting the public benevolent institution (PBI) nature of the organisation
- A strategic plan, which includes an annual operating plan and budget.
- Budgeting, delegation of day-to-day management authority, and segregation of duties.
- The identification and management of risks.

The Executive Board is integral to all the abovementioned internal control processes.



Everyone at MAA takes compliance seriously.

Since the current executive team took over control of MAA back in mid-2012, MAA never missed a compliance activity including meeting the ACNC, ATO, ACFID, State & Federal governments, and financial auditing compliance requirements.

We have a dedicated team who uphold, implement & adhere to both, Islamic values and Australian legislation. These values extend to our field partners.

Our CEO Imam Hassan Elsetohy is qualified in Engineering, Management, Sustainable Systems Design and Islamic Studies. He has many years of experience working in both the corporate and social sectors.

MAA developed what can be considered the world's first systems that conform to both the Australian legislations, Islamic regulation and the ethos of donation management.

These systems are implemented from the ground up in our technology and corporate processes. They are designed to ensure all funds received and disbursed are in full compliance.





ACCOUNTABILITY

Doing the right thing... Right!

It is an essential part of our great religion, Islam, to not only "do the right thing" but to do it "right".

This means that all our actions are accountable,

transparent and professional. We work hard to achieve excellence and above all, sincerity in everything we do.

We continually endeavour to improve the impact of the humanitarian aid we provide around the globe. We seek new and innovative methods and try to establish strong humanitarian relationships to increase the scope of our projects. MAA is continually developing new strategies to reduce operating costs.

Ultimately, we ensure that all stakeholders obtain the maximum impact from the work we undertake.

DIVERSITY

MAA has a strong ethos when it comes to diversity. Our staff comes from diverse cultural backgrounds with highly honed skill sets applicable to all parts/aspects of operations. We speak over 6 languages at MAA!

MAA also has an equitable staff gender balance with approximately 40% of our staff being female.

Since 1989, MAA has operated in over 50 countries without discrimination on the basis of colour, race, ethnic background, gender or religion.



MAARISK MANAGMENT

MAA takes risk-management seriously! Early identification and management of risk is necessary for MAA to continue delivering effective aid in an increasingly complex, challenging and changing environment. MAA adopts world-class risk management methodologies and frameworks, including the guidelines issued by the Department of Foreign Affairs and Trade (DFAT – Aid-Programming Guide, version March 2017) for Risk Management.

Risk management involves thinking about, understanding, regularly monitoring risks, and taking mitigation actions when necessary. It covers due diligence of delivery partners, assessments of partner government financial systems, fraud control, anti-corruption efforts, and child protection and safeguards.

MAA manages risks at the strategic, operational and managerial levels.

What Is Aid Risk Management?


Aid risk management is a process for ensuring that uncertainty does not detract from the delivery of the aid program's objectives. It is an ongoing process that involves:

- identifying and analysing potential risks and opportunities throughout the aid management cycle
- developing proportionate and defensible strategies to balance risk and benefit, and enable sound decisions about whether to start, continue, modify or conclude an aid investment
- monitoring risk—including through internal and external discussions—and updating risk registers; and
- when necessary, escalating risk to the attention of higher decision-makers or forums.

Effective risk management is about being open to, and actively managing, an acceptable level of risk in order to achieve effective development outcomes.

Aid risk management covers due diligence assessment of delivery partners; evaluations of partner governments' financial systems; fraud control and anti-corruption efforts; and safeguards (including environment, child protection, displacement and resettlement).

MAA has adopted the following DFAT Safeguards Compliance Flowchart:



CHILD PROTECTION

In the course of executing aid projects with different partners, contact with children can occur in relation to a broad range of aid projects. While it may not be possible to eliminate all risks related to child exploitation, endangerment and abuse, careful planning and risk management can reduce these concerns considerably.

Safeguarding children refers to the broad obligation of officers and partners to ensure MAA programmes and operations do not expose children to the risk of abuse and exploitation, and that any concerns about children's safety within the communities MAA and partners work in are appropriately reported. Direct and indirect risks to children must be considered as part of the design and implementation phases in MAA projects.





Rebuild: Invest in long-term community development




Water & Sanitation



Our Orphan Aid programme provides quality assistance to orphans regardless of their race, creed, or gender. Every effort is made to ensure that they receive the basic necessities of life.



Our aim is to provide primary healthcare facilities and prevention of disease






Operational Ethos:

To help families maintain a stable income and make a change in their lives, these steps are very important.



MAA's Ramadan programme has evolved over the years to deliver more than just essential Food Aid to poor and needy people around the world during the blessed month of fasting. MAA has now focussed its efforts on expanding the Ramadan distribution to include Income Generating Gifts to beneficiaries to help them break the cycle of poverty.

The Ramadan programme covers families and individuals who are socially, financially, economically, and culturally disadvantaged and distressed. Other than focusing on the poor and needy, we also focus on widows, orphans, the disabled, destitute, and the elderly.



Traditionally, livestock is sacrificed at the point of distribution and fresh meat is given to the beneficiaries immediately. However, MAA also packs Qurban meat in sustainable, long-shelf-life packages that can be distributed where electricity and refrigeration are absent.


Our focus in delivering Qurban Food Aid are the most vulnerable people that include widows, orphans, the elderly, internally displaced people, refugees and the poor.



Despite the best efforts of international aid agencies, the global food crisis continues to spiral out of control, especially in recent years. The direct impact of lack of food on the poor and needy is tremendous and this is the main reason why the food crisis is at the forefront of our agenda in MAA..

Operational Ethos:

MAA is committed to tackling the food crisis and its causes, with the aim of providing people and their communities' access to basic food and aim to make them self-sufficient. We also ensure that Food Aid is culturally appropriate to each country where distribution takes places.

Every human being needs a decent place to live. Without the safety of a home, poverty and its effects damages all aspects of a family, the community, and their overall prosperity.

When disaster strikes, whether natural or manmade, and people are left on the streets with no place to call home, our first response is to accommodate people in Emergency Shelters but we are also committed to more long-term solutions.

Operational Ethos:

MAA builds both Emergency Shelters and Permanent Housing to address both short-term and long-term needs of those affected by disasters. We also undertake rebuilding of homes wherever possible.

Aqeeqah & Sacrifice



MAA conducts Ageegah or General Sacrifice in the neediest areas globally.

It is a Sunnah of the Prophet Muhammad (PBUH) to perform Ageeqah for the child by slaughtering two goats or sheep for a boy and one sheep or goat for a girl, usually on the seventh day after the child is born.

Every year, thanks to this noble activity, thousands of beneficiaries around the world are able to enjoy a nutritious meal that is a change from their usual diet.

With their families struggling to even meet their essential needs like food and shelter, and with many children required to work to help support their families, it is impossible for them to seek and acquire an education.


Many children who do attend school receive an inadequate education because of poorly trained or underpaid teachers, overcrowded classrooms, or lack of basic education tools and books.

Operational Ethos:

MAA strives to educate and up skill people and the communities they live in by providing them essential education and vocational training with the aim to make them self-sustaining and financially independent.

Case Study 1: Somalia Borehole



The Situation

In the past two years, much of Somalia has not received proper rainfall. The ongoing drought and famine situation has caused thousands to lose their lives,

and many thousands of people are finding it extremely hard to survive. So it was very important that MAA reached out with much-needed relief.



The Result


MAA constructed a large scale impactful water project in the Lower Shabelle Region of Somalia. The water project provides clean water to over 5,000 people and their livestock. These were the steps taken:

- Drilling over 120m into the ground
- Testing the water to ensure it's not harmful
- Constructing an area which includes 10 water taps
- Building 3 separate areas for cows, camels, and goats
- Building an area to fill water into tanks to then be transported by donkey carts
- Constructing a generator room to pump the water to the surface
- Constructing a large scale water tank that uses gravity to push the water to the taps and animal feeding areas.

The project involved extensive work, undertaken over several months, to meet the objectives. Thanks to the generous support of our donors, we were able to complete this project successfully.









Case Study 3: Life Changing Gift, Rameesa Beevi



The Situation

40 year-old Rameesa Beevi is a widow living in Sri Lanka. She supports a big family that consists of her mother, her two daughters, and two sons. Her daughters go

to primary school. Since the death of her husband, Rameesa was the sole breadwinner of her family and has been bearing the whole responsibilities of the family, all alone. Until one year ago she was doing reasonably well for herself with a small home-based business involving grinding spices and rice and selling it to shops in nearby towns.

However, all that changed when a disastrous flood struck her home, bringing down her business with it. Most of her personal belongings and equipment related to the business were destroyed, and due to the impending danger she had to move homes.



The Result

Through MAA's stringent assessment process, Rameesa was chosen as part of MAA's Life Changing Gift project to help get her life back on track. Rameesa received a grinding machine and some raw materials, which helped her to restart her business. We also provided her training in packaging and marketing her products effectively.

"MAA offered a helpful hand to me when nobody else was there for me."

"The training has taught me to shop around for the best prices and develop a network of suppliers I can depend upon. I feel really confident about expanding my business now."



Case Study 4: Orphan Aid, Nazish Shahroom



The Situation

Nazish Shahroom is a well-mannered, 7-year old Pakistani girl whose father is deceased. She lives with her mother and studies in Grade 2. As part of our Orphan Aid project, we focus on 5 key areas of orphan

development. These include Food, Clothing, Shelter, Education & Healthcare.



The Results

- The family of Nazish was among the recipients of Food Aid that included flour, sugar, pulses, rice, soap and biscuits that would last them for 2-3 months.
- We also equipped Nazish with warm clothing, sweaters and scarves to keep her warm, especially during the harsh winters.
- A safe shelter is very important for a good upbringing. MAA constructs orphanages which provide a safe place to live. In addition, MAA also repairs the houses of the orphans' families when necessary.
- To ensure her educational needs were taken care of, Nazish received a stationary pack, school uniform and shoes. Her school fees were also paid in full.
- During the year, Nazish visited both a doctor and a dentist who conducted a detail check-up. Both doctors found her healthy and the dentist prescribed some nutritional supplements, which were purchased and handed over to Nazish for use.

The year 2017 was a year of massive growth for MAA's Orphan Aid project. Throughout the year, MAA's orphans were supported and monitored to ensure their needs were being met with the utmost efficiency. Thanks to you, MAA was able to substantially increase the overall number of Orphans that we support. This means that more children are receiving the care they need to be able to focus on their upbringing and build a brighter future.




FINANCIAL REPORTING



PROJECT DISBURSEMENT - PROJECT DISBURSEMENT RATIO




REVENUE - MARKETING & FUNDRAISING RATIO

Qualified Oninion

We have audited the financial report of MAA International Limited (the Company), which comprises the statement of financial position as at 31 December 2017, the statement of comprehensive income and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement by members of the Board.


